Collaboration within the United Nations system and with other intergovernmental organizations

Report by the Director-General

- 1. The WHO Secretariat received a communication dated 21 April 2025 from the Under-Secretary-General for Legal Affairs and United Nations Legal Counsel, addressed to the Legal Counsel of WHO (see Annex 1), according to which, on 17 March 2025 the Secretary-General of the United Nations, in his capacity as depositary of the Constitution of the World Health Organization, had received a letter dated 25 February 2025 from H.E. Mr Gerardo Werthein, Minister of Foreign Affairs, International Trade and Worship of the Argentine Republic (see Annex 2), notifying the depositary of Argentina's denunciation of the Constitution of the World Health Organization. According to this communication, in his letter, the Minister of Foreign Affairs informed the depositary that the decision of Argentina to denounce the Constitution of the World Health Organization was made under the terms of the 1969 Vienna Convention on the Law of Treaties, and that the withdrawal from WHO would be effective one year after the receipt of that letter.
- 2. In her communication, the United Nations Legal Counsel stated that since the Constitution of the World Health Organization does not contain any provision regarding denunciation or withdrawal, and in the absence of any precedent identical to the current situation, the depositary is not in a position to determine whether the notification submitted by Argentina can be accepted in deposit, and that the depositary is prepared to be guided by the action of the World Health Assembly, as the competent organ of WHO, in regard to this matter. The United Nations Legal Counsel also stated that it would be appreciated that the matter be brought to the attention of the World Health Assembly.
- 3. In light of the above, the Director-General has discussed this communication with the Officers of the Executive Board. This situation presents new, complex, and important issues of international law. Bearing this in mind, and mindful of the short time available between the receipt of the above-mentioned correspondence and the Seventy-eighth World Health Assembly, as well as the many items already on the Health Assembly's agenda, there may not be sufficient time for Member States to adequately prepare for, and consider, this matter at the Seventy-eighth World Health Assembly.

4. It is therefore proposed that this matter be considered by the Executive Board, as appropriate, at its 158th session, and for the Executive Board to submit a report on this subject to the Seventy-ninth World Health Assembly.

5. The Director-General also refers to the 23 January 2025 United Nations Depositary Notification¹ which provides that on 22 January 2025 the United States of America notified its withdrawal from WHO, and states that the action would take effect for the United States of America on 22 January 2026 pursuant to the provisions of the Joint Resolution of the Congress of the United States to which the acceptance of the Constitution of the World Health Organization by the United States of America is subject. Any remaining issues regarding this notification and its implications could also be considered by the Executive Board at its 158th session, with a report to be submitted by the Executive Board, as appropriate, to the Seventy-ninth World Health Assembly.

Action by the Health Assembly

6. The Health Assembly is invited to consider the following draft decision.

The Seventy-eighth World Health Assembly, having considered document A78/33 Add.1,

Decided to request the Executive Board to consider the matters addressed in document A78/33 Add.1 at its 158th session, and to submit a report thereon, as appropriate, to the Seventy-ninth World Health Assembly

Further to our conversations on the matter, I have the honour to inform you that, on 17 March 2025, the Secretary-General of the United Nations, in his capacity as depositary of the Constitution of the World Health Organization, received a letter dated 25 February 2025 from H.E. Mr. Gerardo Werthein, Minister of Foreign Affairs, International Trade, and Worship of the Argentine Republic, notifying the depositary of Argentina's denunciation of the Constitution of the World Health Organization.

In his letter, the Minister of Foreign Affairs informed the depositary that the decision of Argentina to denounce the Constitution of the World Health Organization was made under the terms of the 1969 Vienna Convention on the Law of Treaties, and that the withdrawal from the World Health Organization would be effective one year after the receipt of that letter.

Since the Constitution of the World Health Organization does not contain any provision regarding denunciation or withdrawal, and in the absence of any precedent identical to the current situation, the depositary is not in a position to determine whether the notification submitted by Argentina can be accepted in deposit. The depositary is prepared to be guided by the action of the World Health Assembly, as the competent organ of the World Health Organization, in regard to this matter. Accordingly, it would be appreciated that the matter be brought to the attention of the World Health Assembly. The Permanent Mission of Argentina to the United Nations in New York will be informed accordingly.
